

Pedal Paddle and Play 2017

Pedal, Paddle and Play (PP&P) is a community event that combines riding the Seven Waters Trail by bicycle and paddling down the Fox River Water Trail while listening to live music at 3 points along the route. This is the third year for Pedal, Paddle, and Play. This year's event is being sponsored by Runzheimer International. PPP is a fundraising event for bikeburlingtonwi.org, a non-profit 501C-3 groups based in Burlington, WI. This year's event is scheduled on June 24, 2017.

Bicycle riders start to ride from the Seven Waters Trail head (Riverside Park) in Burlington or the Village Hall in Waterford at 10:00am. They can choose to ride a short or long route. The short route runs from Burlington or Waterford to the Rochester (portage/ boat launch) in Case Eagle Park. They can paddle back to Burlington/Waterford in their own kayaks /canoes or ride back to the start. The long route runs from 1) Burlington to Waterford Village Hall or 2) Waterford Village Hall to Burlington. A combination of pedaling and paddling is encouraged. Paddling upstream will not be allowed as part of the event.

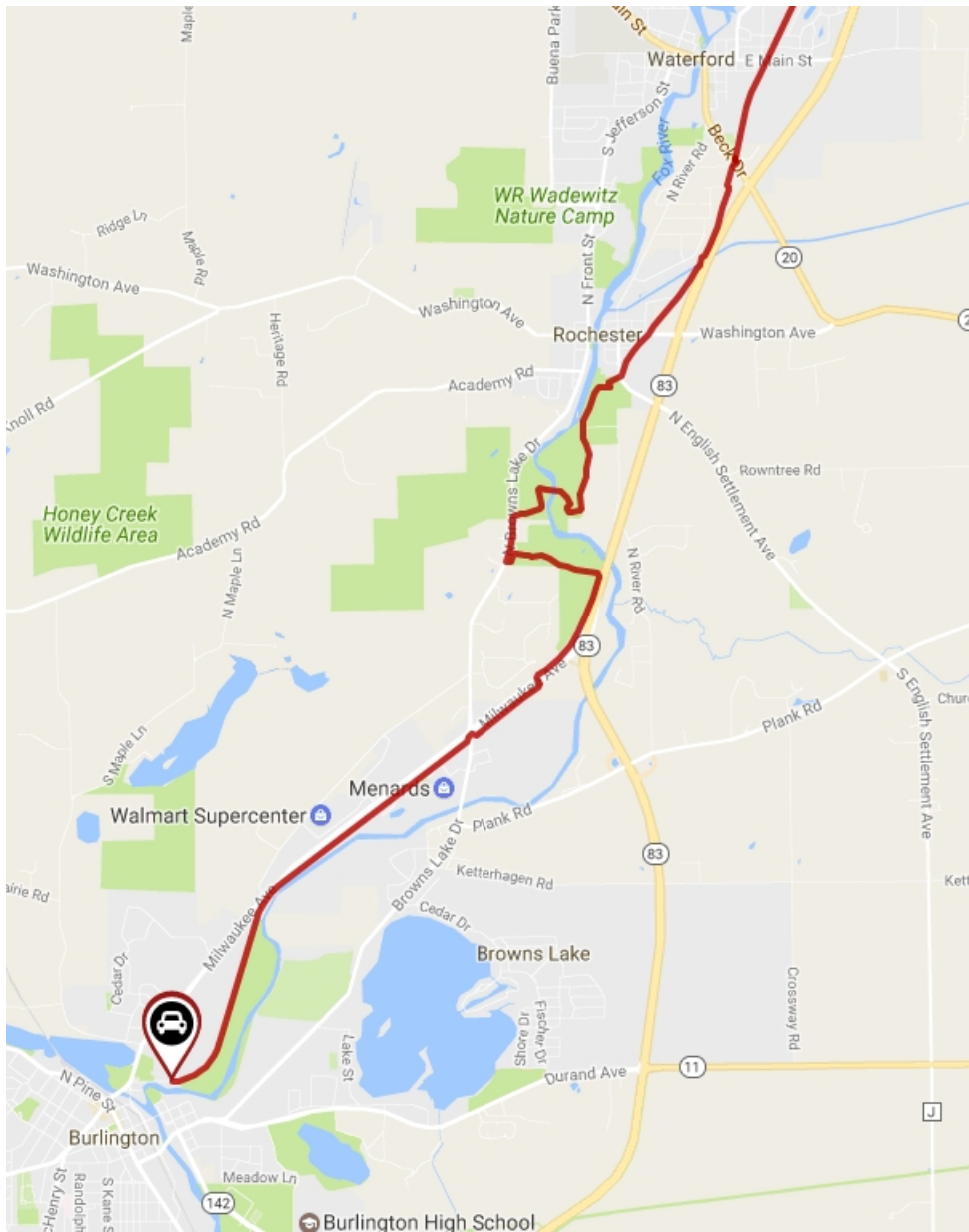
Bikeburlingtonwi will handle shuttling bicycles from drop off paddle points to the next ride point. We are very happy to be working with SherriKayaks this year. Kayak rentals will be available at Village Hall at a reduced price for PPP participants through SherriKayaks. Participants with their own kayaks/canoes, can drop them at Village Hall by 9:00am.

Music will be located at the start in Burlington, Case Eagle Park, and Village Hall in Waterford. Snacks and water will be available at the three locations. The registration area will be located at the start in Burlington. Participant fee is \$10; children 7 and under ride free when accompanied by an adult. Participants will receive a wrist band to identify that they are registered to receive the discount kayak rental.

The route through Waterford will be the Seven Waters Trail to 1st Street, left on First to Main Street, slight left on Main and right on River Street to Village Hall Park.
